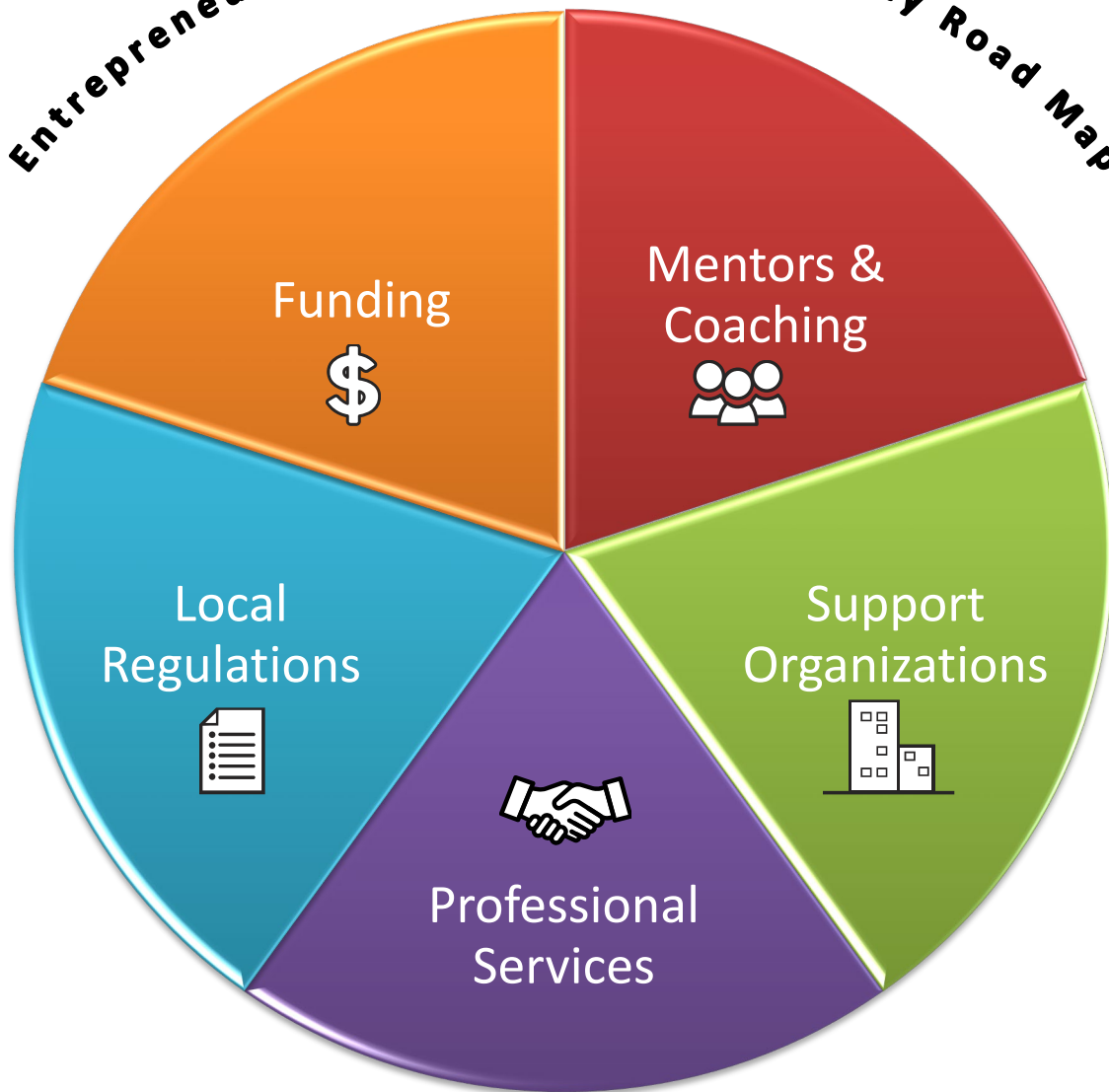


# COLUMBUS AREA Entrepreneurial Ecosystem / eCommunity Road Map
